Background

The St Agnes BMX track is located at 240 Smart Road, St Agnes. The site includes a BMX track and transportable buildings (consisting of a canteen, meeting room and toilet facilities) for use by the Tea Tree Gully BMX Club (TTG BMX).



TTG BMX was established in 1982 and currently has 90 members. They are currently the only hirer of the St Agnes track, using the track 2 – 3 times a week in summer and 1 – 2 times per week in winter.

Currently, TTG BMX Club is the only BMX club in the state without floodlighting, limiting its capabilities for training session and opportunities to hold regional and state racing events.

Lighting proposal

The lighting design proposes installation of 5 x 15 metre poles with 15 x optiLED light fittings (3 fittings per pole) to achieve an average of 220 lux within the track area.

The lighting design takes careful consideration into the sensitive nature of spill light to the adjacent properties and has been designed in accordance with the relevant Australian Standards. The lighting design for the St Agnes BMX track indicates a light spill beyond the perimeter of the St Agnes Recreation Area of between 0.1 – 1 lux.

The total cost of installing permanent floodlighting at St Agnes BMX track is \$140k. In the 2019/2020 financial year Council has allocated \$90k funding, the TTG BMX Club will contribute \$25k and \$25 will be from the Office for Recreation, Sport and Racing Active Club grant program.

The installation of floodlighting at the St Agnes BMX track will assist the Club to increase its membership base and offer evening sessions under lights. It is proposed that the increased hours of use will occur under the existing usage schedule of 2 to 3 times per week in summer and 1 – 2 times per week in winter, which incorporates weekend usage.

Legislative requirements

As the existing Community Land Management Plan for St Agnes Recreation Area, in which the St Agnes BMX track is listed, does not include floodlighting, the plan would need to be amended. Section 198 (2) of the Local Government Act states that an amendment to the Community Land Management Plan requires community consultation, with section 198 (3) of the *Local Government Act 1999* states if there is no impact then consultation is not required. As the installation of floodlighting at St Agnes BMX track is considered as having an impact on the community, consultation is therefore required.

Community engagement

Community engagement was undertaken to understand the views of local residents, users of St Agnes Recreation Area and the broader community on the proposed installation of floodlighting at the BMX track, and to meet the above mentioned legislative requirements.

At its meeting on 8 October 2019 Council endorsed community engagement to be undertaken on this proposal in accordance with Section 198 of the *Local Government Act 1999*.

A Community Engagement Strategy was developed by the Community Development Engagement Department, in line with the requirements outlined in Council's *Community Engagement Public Consultation Policy*.

Overview of community engagement activities

From 28 October to 22 November 2019 the community was invited to provide feedback on a proposal to install floodlighting at the St Agnes BMX track.

Various marketing and communications methods were undertaken to advise the community of the opportunity to provide feedback including:

- A notice to the public in the North-NorthernEastern Messenger on 28 October (see Attachment 3)
- Social media post via Council's Facebook account
- Signage placed onsite of St Agnes BMX track (see Attachment 3)
- Direct mail out to 157 households/property owners in an approximately 200 metre radius of the boundaries of St Agnes Recreation Area (see Attachment 1) inviting feedback to be provided online. A hard copy feedback form was available on request (see Attachment 4 for a copy of the letter & lighting design plan and Attachment 5 for the feedback form)

All communications referred people to Council's 'Have Your Say' website where further information could be accessed. This included:

- an information sheet about the proposal
- an online feedback form
- a 'Q&A' form where people could ask questions about the proposal. Once answered these questions and Council's response are publicly available.

Community engagement outcomes

During the consultation period a total of 133 responses were received by Council regarding the proposal. One response was not included as it was considered invalid due to no contact details being provided. Five responses were removed as they were additional responses received from the same individuals; feedback was merged where appropriate.

This left a total of **127 responses** that have been considered valid for the purposes of this report.

Categorisation by respondents' residency

For the purposes of this report, the response data has been categorised as follows:

- Respondents in the mailout area (as depicted in Attachment 1) (n=8)
- Respondents outside the mailout area (as depicted in Attachment 1) within the City of Tea Tree Gully Local Government area (n=64)
- Respondents outside the City of Tea Tree Gully (n=53)
- Respondents unable to be identified due to insufficient address details provided (PO Box or email only) (n=2)

Connection to the area and the TTG BMX Club

Respondents were asked which best describes you from the following options. They could select more than one option:

- Twenty (20) were outside the City of Tea Tree Gully (other LGAs)

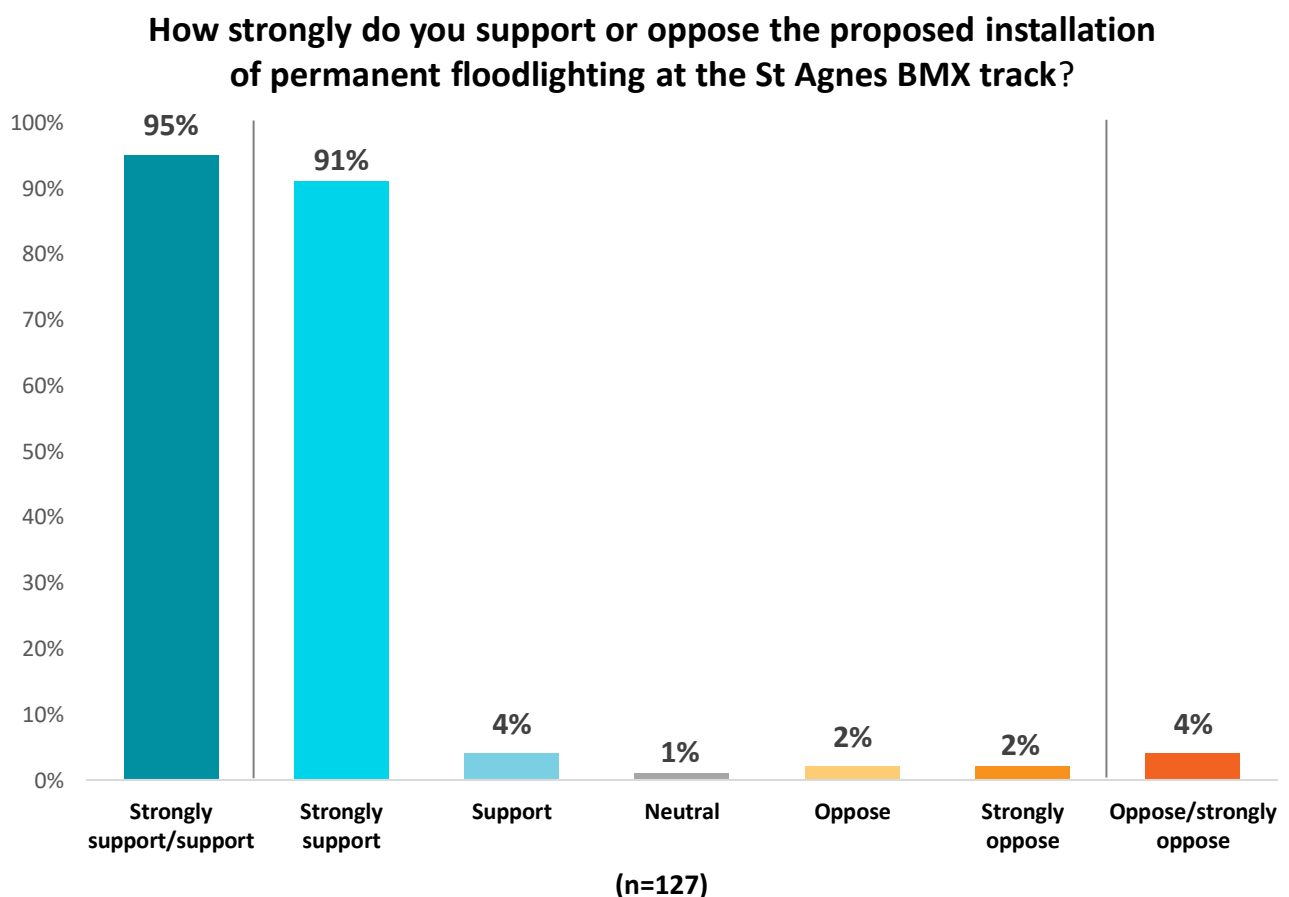

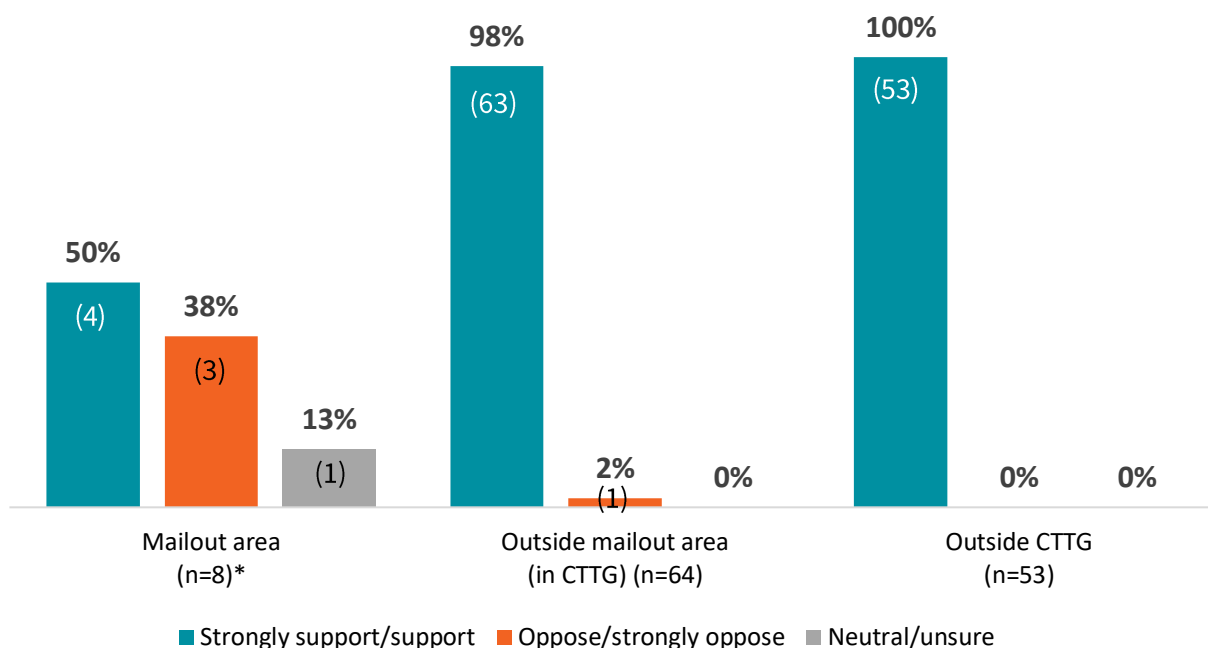

All eight (8) respondents identified as living in the mailout area reside south of the St Agnes BMX track and Recreation Area.

Note: Numbers in brackets represent number of responses. Due to the small size of the group (n=2) those with unknown residency are excluded from this graph.

Summary of key themes from responses to ‘why do you say this?’

Of the 127 responses received, 119 responded to the question: **Why do you say this?**

The key reasons for why respondents said they ‘Support’ or ‘Strongly support’ were:

- Will allow after hours coaching & training/safely/during winter & hot weather/for those who can’t attend during day/working parents (n=51)
- Will allow more events to be supported/hosted at night/more flexibility for scheduling races (n=40)
- Increase participation/encourage outdoor activity/all year round/for kids (n=29)

The key reason for why respondents said they ‘Oppose’ or ‘Strongly oppose’ was related to concern about noise at night from the PA system/is currently loud on weekends/during the day/intrudes on private living space (n=3)

The Tea Tree Gully BMX Club has asked Council to consider the installation of permanent floodlighting at the St Agnes BMX track, located at 240 Smart Road, St Agnes. We are now seeking community feedback on this proposal.

The proposal

The Tea Tree Gully BMX Club (TTG BMX) was established in 1982 and currently has 90 members. They are the only hirer of the St Agnes BMX track and currently use the track 2 to 3 times a week in summer and 1-2 times per week in winter.

Currently the TTG BMX Club is the only BMX club in the state without floodlighting which limits the clubs' capabilities for training sessions and opportunities to hold regional and state racing events.

Council is proposing the installation of five (5) x 15 metre poles with 15 optiLED light fittings (3 fittings per pole) to achieve an average of 220 lux within the track area (refer to enclosed lighting design).

The total cost of the installing permanent floodlighting at St Agnes BMX track is \$140,000. In the 2019/2020 financial year Council allocated \$90,000 funding towards this project; the TTG BMX Club will contribute \$25,000 with the remaining \$25,000 to come from the Office for Recreation, Sport and Racing Active Club grant program.

The installation of floodlighting at the St Agnes BMX track will assist the Club to increase its membership base and to hold evening training sessions under lights. It is proposed that the increased hours of use will occur under the existing usage schedule of 2 to 3 times per week in summer and 1-2 times per week in winter, which includes weekend usage.

Amendment to Community Land Management Plan

Installation of permanent floodlighting to the St Agnes BMX track would require an amendment to the Community Land Management Plan for the St Agnes Recreation Area, in which the St Agnes BMX track is listed. Council is required to consult with the community for such an amendment.



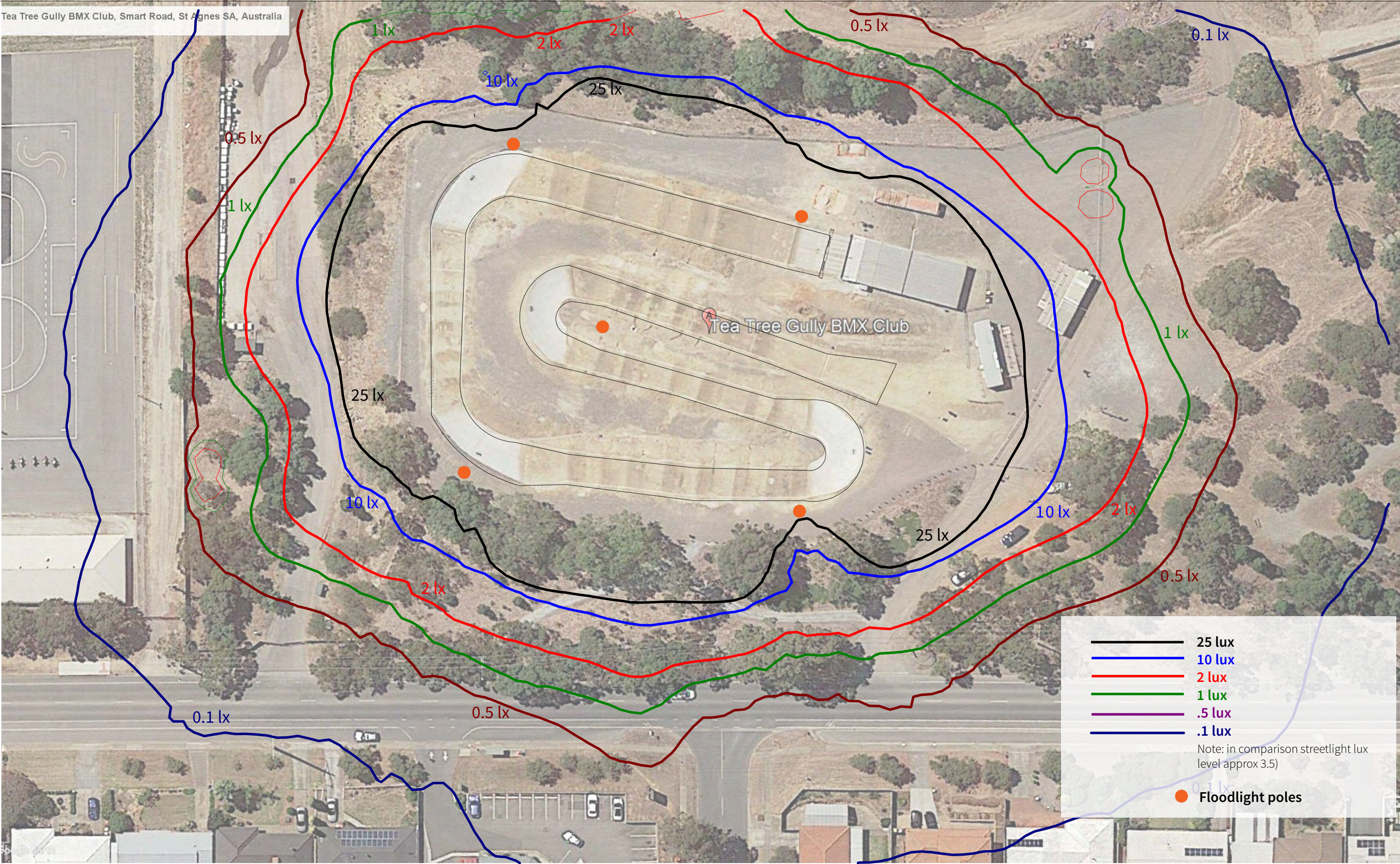
